- i) Weightage will be given to candidates having higher qualifications, experience in the nature of duties attached with the post, knowledge of computer and extra curricular activities

1. **AGE LIMIT AS ON: 01.01.2010:** - Not exceeding 30 years for Sr. No. 1 and 25 years for Sr. 2.
  2. No age relaxation will be given to the employees of Board/Corporation/Autonomous Bodies etc.
  3. **APPLICATION FEE:** A fee of **Rs. 100/- for General and O.B.C Categories** as non-refundable, in the shape of demand draft **payable at Chandigarh** drawn in favour of **Director, Regional Institute for Mentally Handicapped, Sector 31, Chandigarh.
